I am a resident of Sherman County. I started researching when it was brought to my attention that suspicious donations occurred with political donations on the Federal Election Commission website, FEC.com. It seems donations are assigned to people who gave a couple times and their records now show an amount significantly more than they donated. According to FEC records, the people we are researching have given 50 times or more in a year. It seems a larger donation was given and it's being shown as small donations from many individuals who did not make the donation. This illegal activity is considered smurfing or money laundering. Most people find this money was not taken from their account rather their names were used to hide other larger donations or foreign funds to American political races which is illegal!

According to the FEC.gov (Federal Election Commission) website, you seem to have made: 72 donations during the years 2019-2022

Totaling \$644.02.

According to the FEC website some of the recipients to these donations include ACTBLUE.

Do you believe this to be true? Do you feel that someone may be taking advantage of your name? I'm here because your name is on that list of frequent donors, and I wanted you to know.

We believe there are thousands of Nebraskans in our counties that have their identity being used to launder money. The money goes to various political entities including PACs like WinRed and ActBlue or even out of state politicians like Warnock for Senate and Kevin McCarthy for House of Representatives. In fact, this is occurring in every state across our country. We are unsure where the money originates, but we know millions of dollars can be shown on the FEC.gov website that it is in fact occurring.

- Here is how to search for people on the Federal Elections Commission website
 Key into your URL the following: fec.gov
- Locate at the top, a drop-down menu called Campaign Finance Data
- Select All data.
- At the bottom you'll find 8 blue boxes with one being "Raising"
- Select that blue box.
 In the middle of the page, select Individual contributions.
 It is within this screen you can do all your searches.

On the left side of the page are your filters. The default is set at looking at 2021-2022, so if you want to pull in more years navigate down to the heading named **RECEIPT DATE RANGE**. You will need to key in the <u>start</u> and <u>end</u> years in the boxes below. The easiest way to filter your search down is through Zip Code. Perhaps select that and then look up your last name. To the right is the data. At the bottom of the data is a choice to view 30, 50, or 100 records. If you have a lot, switch your view to 100. If your search has even more records, at the top of the records area in the right-hand corner is the Export button. Click it.

Once clicked, at the bottom of the page you will see another small blue box that reads "Download". Once it's done assembling your chosen records click the button. A .csv file will download at the bottom of the page, and you can select that file to open it up.

Please review your records and if you have not donated this amount of times and total dollar amount please call me as I would like to speak with you to find out the details and add you to the list of individuals in Nebraska that seems to have inaccuracies in reported donations and need further investigation.
