I. JURISDICTION AND VENUE

- THIS IS A CIVIL ACTION AGAINST THE Nebraska Department of
 Corrections (N.D.C.S.) and any named officials for violating the plaintiff's
 constitutional rights under Article 1 section 5 of the Nebraska Constitution and
 other applicable Nebraska laws. Plaintiff seeks injunctive relief and declaratory
 relief to prevent further violations of his constitutional rights.
- 2) The court has jurisdiction under Neb. Rev. Stat. 24-302 because the matter involves constitutional issues deriving under Nebraska law.





3) Venue is proper in this court under Neb. Rev. Stat. 25-403.01 because the actions given rise to the complaint occurred in Lancaster County, Nebraska.

II. PLAINTIFF

4) Plaintiff, Nicholas J. Ely, is and was at all times mentioned herein as a prisoner of the State of Nebraska in the custody of the Nebraska Department of Corrections. He is currently confined in the Reception and Treatment Center (R.T.C.) in Lincoln, Nebraska.

III. DEFENDANTS

- 5) Defendant, Rob Jeffreys, is the Director of the State of Nebraska Department of Corrections. He is legally responsible for the overall operation of the Department and each institution under its jurisdiction, including the Reception and Treatment Center.
- Defendant, Targgart Boyd, was the Warden of the Reception and Treatment

 Center at the time when this complaint began. He is legally responsible for the operation of the Reception and Treatment Center and for the welfare of all the inmates in that prison.
- Defendant, Craig Gable, is the current Warden of the Reception and Treatment Center. He is legally responsible for the operation of R.T.C. and for the welfare of all the inmates in that prison.

- 8) Defendant, Shawn Freeze, is a Deputy Warden at the Nebraska Department of Corrections who, at all times mentioned in this complaint, held the rank of Deputy Warden and was assigned to R.T.C.
- 9) Defendant, Eric Steigger, is an Associate Warden at the Nebraska Department of Corrections who, at all times mentioned in this complaint, held the rank of Associate Warden and was assigned to R.T.C.
- Defendant, Frank Howard, is an Intelligence Captain of the Nebraska

 Department of Corrections who, at all times mentioned in this complaint, held
 the rank of Captain and was assigned to R.T.C.
- Defendant, Taylor Kester, is a Unit Manager at the Nebraska Department of Corrections who, at all times mentioned in this complaint, held the rank of Unit Manager and was assigned to R.T.C., housing unit F.
- Defendant, Brittany Sherlock, is a Case Manager at the Nebraska Department of Corrections who, at all times mentioned in this complaint, held the rank of Case Manager and was assigned to R.T.C., housing unit F-1.
- 13) Each defendant is sued individually and in his/her official capacity. At all times mentioned in this complaint, each defendant acted under the color of state law.

IV. FACTS

On July 14, 2023, Plaintiff was transferred from the Tecumseh State

Correctional Institution (T.S.C.I.) to the Reception and Treatment Center's

"384-bed" controlled management unit.

- 15) Because inmates are only allowed out of their rooms for 3 hours per day, plaintiff decided to utilize the remaining hours of his day in a productive manner by writing a book.
- 16) Approximately a year later, the manuscript was finished and plaintiff mailed it to Julie Montpetit (then girlfriend, now wife) who published it in August of 2024 under the title "The Prisoner Manifesto."
- Plaintiff then purchased a copy of the book for himself through the company
 Barnes and Noble, but the prison administration denied it from entering the
 facility and confiscated it.
- 18) Plaintiff grieved this decision using the informal grievance procedure and learned his book had been deemed to "promote security threat group ideology."
- 19) Plaintiff disputed the accusation by filing a formal step one grievance, to which the response stated that the book was still "under review" and that it had not yet been denied entry.
- 20) Plaintiff abandoned the grievance series at this time as he waited to see what the decision from the review would be.
- 21) No prison employee ever stated to the plaintiff verbally or in writing that having a book published was a violation of the department rules and regulations.
- In fact, the plaintiff was congratulated by Associate Warden Sloup "face-to-face" for becoming a published author. He stated he was glad that the plaintiff had found a way to spend time wisely and out of trouble.
- 23) No immediate answer was provided as to the approval/denial of the book.

- On November 14, 2024, the plaintiff's then fiancé, Julie Montpetit, released on Apple Podcasts and Spotify an episode of her new podcast called "More Than an Inmate's Girlfriend." Her podcast interviews people from all over the world who have loved ones who are or were incarcerated to discuss the dynamic within these relationships, as well as humanize the inmate population and normalize the people who love them.
- 25) To establish her credibility as an actual "woman who is in a relationship with an incarcerated man," Julie Montpetit interviewed the plaintiff over the prison phone. These calls are monitored/recorded by the prison and nothing bad was spoken about the institution.
- 26) Plaintiff did not exploit his crime, nor did he receive any compensation for this interview. (see Exhibit #1 for the interview transcript)
- 27) The podcast is harmless and speaks about love, so neither party thought that this interview would upset the prison administration. There are no rules/regulations that restrict inmates from being interviewed for a podcast.
- 28) However, on the day of the episode's release (11-14-24), plaintiff's cell was raided by defendant, Intel Captain Frank Howard, who removed everything from the plaintiff's cell (including his mattress and pillow) to be searched in headquarters. At the time of this search, plaintiff had not yet been informed as to "why" his cell was being raided.
- 29) By the end of that day (11-14-24) half of plaintiff's property was returned to him but defendant, Intel Captain Frank Howard, held the plaintiff's medicinal glaucoma eye drops, personal writings, books, and all of his personal hygiene supplies- for four days. For those four days, the plaintiff went without

- toothpaste, soap, shampoo, deodorant, lotion, and- despite having submitted Emergency Grievances- his eye drops that he'd been prescribed to use 5X a day to alleviate migraines and high eye pressure.
- November 14, 2024, was the date that the plaintiff began receiving retaliation from the prison administration for practicing his freedom of speech and association. From 11/14/24 to the present moment, the plaintiff has been suffering irreparable harm caused by this retaliation that violates his First, Fifth, Eighth, and Fourteenth Amendment rights, described herein.
- On November 18, 2024, four days later, all of the plaintiff's property was returned to him following the completion of the search.
- 32) This same day, the administration deleted Julie Montpetit from the plaintiff's phone list and email account. The N.D.C.S. administration prohibited the plaintiff from calling or emailing his fiancé.
- 33) The N.D.C.S. administration also removed Elzabeth Hettrick (friend) and the plaintiff's mother, Greta Ericson, from his email account.
- 34) All of these restrictions took place without reason or notice on 11-18-24.
- 35) The plaintiff submitted an Inmate Interview Request (I.I.R) to the Warden, defendant, that same day concerning these restrictions.
- On November 19, 2024, defendant, Intel Captain Frank Howard, had a meeting with the plaintiff concerning these restrictions. Defendant, Unit Manager Taylor Kester, was present during this meeting.
- 37) In summary, Intel Captain Howard told the plaintiff that he had read the plaintiff's book and that the podcast interview had caused a "knee jerk

- reaction" from the administration, and informed the plaintiff that he needs to be more transparent with the administration moving forward.
- admits to the plaintiff that maybe the administration had overreacted a little bit and said he'd have a talk with the Warden about reversing the decision to censor the plaintiff's communications. He stated that ultimately the decision to reverse belongs to the Warden and recommended that the plaintiff appeal this decision to defendant, Warden Taggart Boyd.
- The plaintiff then asked Intel Captain Howard why Greta Ericson (mother) and Elizabeth Hettrick (friend) were deleted from his email, as they had nothing to do with the publishing of his book or podcast. Intel Captain Howard acted confused, then stated "those two were never meant to be deleted. If this is true, it was a mistake that I'll fix immediately." (See Exhibit #2, a declaration of the conversation held between the plaintiff and the defendant, Intel Captain Frank Howard.)
- On November 20, 2024, defendant Deputy Warden Shawn Freese, approached the plaintiff's cell to have a conversation concerning the restrictions, but his tone was nothing similar to Intel Captain Howard's from the day before.

 Whereas Intel Captain Howard had said there was nothing really "wrong" per se with what the plaintiff had done, Deputy Warden Freese began the conversation with threats of solitary confinement if the plaintiff were to "keep it up," stating that solitary confinement is still an option that is "on the table."
- 41) The plaintiff responded to Deputy Warden Freese by asking which policy had ben violated for him to be threatening the use of solitary confinement, to which

Deputy Warden Freese stated "the common-sense policy" and that the plaintiff needs to "knock it off." Deputy Warden Freese stated the podcast had "crossed the line," claiming it to be "anti-establishment, anti-authority, anti-government," therefore it won't be tolerated.

- The plaintiff responded "have you taken the time to listen to it? The podcast is about none of those things, it's about love"
- 43) The plaintiff was then threatened by Deputy Warden Freese to receive "continuous misconduct reports" until the podcast was removed, as well as a letter from the N.D.C.S. "legal team." (See Exhibit #3, declaration of conversation held between the plaintiff and defendant, Deputy Warden Shawn Freese)
- On November 21, 2024, the plaintiff received a response via institutional mail from the initial I.I.R. that he'd submitted on 11-18-24 when these restrictions first occurred. The response came from defendant, Deputy Warden Freese, instead of Warden Taggart Boyd, and stated:

"This has been reviewed and the restrictions will stay in place. Engaging in a podcast or other enterprises will not be tolerated." (See Exhibit #4 for this I.I.R. response)

or other enterprises, nor had any idea that he'd done something considered a violation of regulations until Deputy Warden Freese informed him that the podcast had "crossed a line."

- though there are no policies that prohibit an inmate from writing a book or being interviewed for a podcast. There are no policies because the First Amendment protects freedom of speech and association.
- The plaintiff submitted several informal grievances concerning these restrictions that began the exhaustion remedies, accusing the N.D.C.S. administration of harassment and retaliation, but none of the formal step one grievances concerning this matter have been answered or returned.
- The plaintiff submitted an I.I.R. to defendant, Warden Taggart Boyd, for three consecutive days (11-21-24, 11-22-24, 11-23-24) concerning these communication restrictions, to which he responded to them all on 11-26-24. In summary, defendant Warden Taggart Boyd approved the restrictions after being notified about the podcast but assured he would "review the situation" in the next week.
- On November 24, 2024, the plaintiff submitted an I.I.R. to visiting staff to inform them of his intent to be married on 12-25-24 (which was the assigned visiting date for the plaintiff's housing unit) and, because it would be Christmas Day, the plaintiff provided efficient notice to prepare in case any additional staff be needed.
- That same day, the plaintiff requested a "marriage application" from defendant Case Manager Brittany Sherlock, who provided the application upon request.
- 51) Upon submission, defendant Case Manager Brittany Sherlock recommended that our marriage application be denied by telling the Warden that:

"Ely, Nicholas #77049 and Julie Montpetit have

both been found to be in violation of N.D.C.S. rules and regulations by working together to create a business while Ely #77049 is incarcerated with the writing of his STG related book, running a podcast, and making 3-way calls; all of which are evidenced in the attached MR and grievance. Ely continues to encourage other individuals on the unit to participate in his podcasts and shows no regard for the rules of this institution." (See Exhibit #5)

- 52) This statement is a list of false allegations because:
 - a. The plaintiff doesn't run/own a podcast;
 - b. Julie Montpetit has never made any 3-way call for the plaintiff;
 - c. Publishing a book is not operating a business;
 - d. The plaintiff did not "continue to encourage other individuals on the unit to participate" in the podcast;
 - e. The plaintiff does show regard for the rules of the institution, which is proven by the incentives he's earned for good behavior and lack of misconduct report history.
- This report was fabricated as an act of retaliation against the plaintiff for practicing his freedoms of speech and association in an attempt to deny the plaintiff his right to get married.
- 54) On December 6, 2024, defendant Warden Taggart Boyd denied the plaintiff's marriage application, violating his right to marriage.

On December 13, 2024, the plaintiff submitted an I.I.R. to defendant Warden
Taggart requesting that the decision to deny the marriage be
reviewed/reversed because "writing a book" and being interviewed for a
podcast do not serve as legal grounds to deny someone their First Amendment
right to get married. However, defendant Unit Manager Taylor Kester
intercepted the I.I.R. from the institutional mail and responded herself,
stating:

"Per policy 205.4, if the Warden deems the marriage to be a threat to the safety, security, or good order of the facility it may be denied." (See Exhibit #6)

- The plaintiff submitted an informal grievance upon receiving this response, grieving how unit staff are intercepting I.I.R.'s that are addressed to the Warden- who is the only employee with the authority to review/reverse an administrative decision.
- 57) On December 15, 2024, Julie Montpetit emailed the Warden to plea for him to reverse the denial of the marriage application.
- On December 16, 2024, defendant Associate Warden Eric Steigger responded to Julie Montpetit's email, telling her that the denial of the marriage application related solely to "staffing issues" and is not meant to reflect her negatively in any way.
- After claiming that the marriage was denied due to "staffing issues" and that it was not meant to reflect Julie Montpetit negatively in any way, on December 18, 2024, the defendants denied the plaintiff's entire visit scheduled for

- Christmas Day, providing no "reason" for why they denied Julie Montpetit and William Ely (father) to visit.
- on The defendants had no legitimate reason to deny the plaintiff's Christmas Day visit, which he had earned as an incentive to his good behavior. "Staffing" was not an issue at all and every other inmate received their visits that day. Only the plaintiff's visit was denied.
- 61) Defendant Associate Warden Eric Steigger had lied to Julie Montpetit about why the marriage was denied.
- The plaintiff submitted an I.I.R. to defendant Unit Manager Taylor Kester that requested an explanation as to why his Christmas Day visit had been denied with his father and Julie Montpetit.
- 63) On December 20, 2024, defendant Unit Manager Kester replied:

"Your visit with your father is not denied. I see you put in another form." (See Exhibit #7)

- The plaintiff had <u>not</u> put in another "form" but attached to this I.I.R. was a new Visiting Request Form that defendant Unit Manager Kester had forged in the plaintiff's name, acting as if the plaintiff had filled it out. (See Exhibit #8) and (See Exhibit #9, for declaration)
- By this date, the plaintiff's father had already made new plans for Christmas after hearing that the visiting request had originally been denied, so he wasn't able to visit.
- 66) Julie Montpetit wasn't allowed to visit, but no reason was provided for her denial. (See Exhibit #10)

- 67) The plaintiff was denied his visit and his marriage on 12-25-24 as retaliation for practicing his freedom of speech and association, as well as for utilizing the grievance system.
- Additionally, during that month of December, on 12-17-24 the plaintiff submitted a grievance as "sensitive" (private) in order to be reviewed by the defendant, Director Rob Jeffreys, because the plaintiff began to fear that the N.D.C.S. administration was violating his First Amendment rights and retaliating against him for grieving these violations. The plaintiff requested Director Rob Jeffreys to please not allow the Warden to deny the wedding, explaining how Julie Montpetit presents no threats to the institution, nor would our ceremony, but the Director's Designee refused to review the plaintiff's complaint due to the plaintiff having already began the grievance procedure.
- 69) Because the plaintiff's grievances and several I.I.R.'s had received no responses over a month's wait, the plaintiff began documenting his own records of everything he submitted on January 1, 2025.
- On January 3, 2025, another friend of the plaintiff, Melissa Breckenridge, was deleted from his email list. The defendants provided no reason or notice for this restriction. The plaintiff submitted an informal grievance complaining about this censor but it was never answered.
- On January 6, 2025, the plaintiff submitted his second marriage application to defendant Unit Manager Taylor Kester "face-to-face" so that they couldn't claim they never received it.

- 72) Upon submission, Unit Manager Kester asked the plaintiff "why are you turning in another marriage application after the first one was denied?"
- 73) The plaintiff responded, "so that I can get married this month as there's no reason why the ceremony wouldn't be approved."
- 74) Unit Manager Kester stated, "Julie Montpetit's visiting status has been restored but the Warden still isn't going to approve your wedding."
- 75) The plaintiff responded, "I didn't know her visiting status had ever been in question. For what reason would it be? Associate Warden Steigger told Julie that the only reason our wedding was denied on Christmas was due to staffing issues."
- 76) Unit Manager Kester then said, "if that's what Steigger said then I'm just gonna shut my mouth." (See Exhibit #11, declaration of conversation between the plaintiff and the defendant, Unit Manager Taylor Kester)
- 77) Unit Manager Kester accepted the marriage application to be submitted for approval on that date, 1-6-25.
- 78) No reason was provided for why Julie Montpetit had been denied the

 Christmas Day visit with the plaintiff until defendant Unit Manager Taylor

 Kester responded to the I.I.R. on January 7, 2025, stating:

"She was denied because the marriage was denied. A full review was done to see if she could continue to visit. At this time she will be allowed to continue to visit. That is always subject to change." (See Exhibit #12)

79) This response was a subtle threat. The defendants have been using the plaintiff's visits, marriage, and associations with loved ones (phone/email) as

- weapons to retaliate against the plaintiff for publishing a book and being interviewed for a podcast.
- 80) On this same day, 1-7-25, the plaintiff requested the names of the defendants of this complaint, as well as their job titles, but defendant Unit Manager Taylor Kester replied: We are not required to provide that information. You may file a petition." (See Exhibit #13)
- 81) This response delayed the plaintiff's access to the courts, as the N.D.C.S. administration (the defendants) had already prohibited most of his outside communications. The plaintiff worried that if he asked a loved one to retrieve this public information for him that the defendants would retaliate by removing them from his phone and/or email list.
- 82) On January 8, 2025, the plaintiff admittedly engaged in a 3-way phone call via his brother and a radio show out of Portland, Oregon in order to talk about the book he had published and how the defendants had been retaliating against him for it.
- 83) Julie Montpetit had no involvement with the 3-way call.
- On January 10, 2025, defendant Intel Captain Frank Howard wrote a misconduct report against the plaintiff for having his brother make a 3-way call and stated in the report that the plaintiff "had neither permission nor authorization to be in contact with a public media outlet." As punishment for this misconduct report, the plaintiff received "7 days of canteen restriction."
- 85) Later on, that same day (1-10-25), defendant Deputy Warden Shawn Freese emailed all of the defendants, telling them to temporarily suspend the plaintiff's visits with Julie Montpetit. No reason or notification was provided

for this suspension but the correlation between 1-10-25 being the same date defendant Intel Captain Howard discovered that the plaintiff had spoken with a media outlet and 1-10-25 being the date that Deputy Warden Freese suspended all visits with Julie Montpetit proves that this suspension was further retaliation against the plaintiff for speaking to the public.

- 86) The only incident which had occurred since the "full review" (approval) of Montpetit's visiting status from three days earlier was the 3-way call that the plaintiff's brother made for him, an incident that had nothing to do with Julie Montpetit (See Exhibit #14, for declaration)
- 87) Defendant, Unit Manager Taylor Kester's "subtle threat" had now been fulfilled. (See point #78-79 above)
- 88) After two months of complaining about it, the plaintiff's mother had her email account reinstated on January 12, 2025.
- 89) It took Intel Captain Frank Howard two months to fix his alleged "mistake" but Elizabeth Hettrick (friend) is still deleted from the plaintiff's email account.
- Two months prior, Intel Captain Howard had said this deletion was a mistake, as well as the mother's deletion, but now the plaintiff has been informed that Elizabeth Hettrick is a "threat to the safety, security, and good order of the institution." However, the plaintiff has never been informed as to what makes her a threat, nor has the formal step one grievance been responded to. (See point #39 above)
- During the month of January (2025) the plaintiff received no responded to any informal or formal grievances that he'd filed. The defendants have also stopped responding to the plaintiff's I.I.R.s after learning of the plaintiff's intent to file

- a lawsuit. The plaintiff complained about the lack of responses to the Warden (defendant) on January 14, 2025, but nothing has changed.
- Additionally, since the defendant's retaliatory behavior began and in response to the plaintiff's grievance submissions, all of the plaintiff's laundry was mysteriously lost/misplaced throughout the months of December (2024) and January (2025).
- 93) By mid-January, the plaintiff no longer had any clothes of his own, nor did he have any more laundry bags assigned to his cell. All of his clothing had been "lost in laundry". Laundry is sorted out and delivered by unit staff outside the presence of inmates.
- The plaintiff had submitted two different "lost clothing form" requests to defendant Case Manager Brittant Sherlock and had complained repeatedly that he had no clothing items, but the plaintiff's complaints were ignored.
- 95) Throughout this time, the plaintiff was forced to borrow clothes/laundry bags from other inmates, which is technically against the rules, but the plaintiff had no other option available.
- but nothing was done about this complaint until the plaintiff's father, William Ely, began emailing and calling the defendants. William Ely raised this complaint via email on January 17, 2025, and spoke to defendant Case Manager Brittany Sherlock via telephone on January 28, 2025. William Ely then spoke with defendant Unit Manager Taylor Kester concerning the plaintiff not having any laundry but the issue was still not resolved.

- 97) William Ely then sent an email to communications and the Director's Designee Robert Madison on January 30th 2025, explaining how the plaintiff had been complaining for over a month to the defendants about how he has no clothing.
- 98) In the first week of February (2025) the plaintiff was delivered a brand-new wardrobe of clothing, inside of a laundry bag. Upon taking this bag of clothing to his cell and opening it, the plaintiff discovered that someone had dumped a large pile of "freshly trimmed" hair into his bag of brand-new clothes.
- 99) Because the clothing items were all brand new, the plaintiff believes this pile of hair was dumped into his clothing as harassment/retaliation by the defendants. However, after the clothes made it through the wash, the plaintiff now has clothing.
- 100) Back to the chronology of events, on January 17, 2025, every inmate except for the plaintiff received their "visiting request form" decision that notifies as to whether their visit has been approved/denied for the pre-scheduled date of 1-27-25. The plaintiff was the only inmate who requested a visit but didn't receive a response.
- Decause the plaintiff's father lives two hours away and Julie Montpetit lives in Canada, all parties, involved needed to know whether the visit had been approved or denied. Given how the defendants had denied the plaintiff's Christmas Day visit/marriage a month prior without cause, nobody knew whether this month's visit would be approved and the plaintiff still hadn't received an answer from the marriage application he'd submitted on 1-6-25.
- 102) Every day the plaintiff would ask defendant Unit Manager Taylor Kester to produce an answer but the defendant's response was "the Warden has made

- his decision already but it's still sitting on his desk and I haven't had time to pick it up." After explaining to the defendant, the urgency of the matter, the plaintiff asked Unit Manager Kester to "please call and ask, or send an email", but Unit Manager Kester said "it doesn't work like that."
- 103) Because every other inmate had already received their answer, the plaintiff believes the defendants were intentionally stalling to inform him of the Warden's decision until the last moment, knowing that Julie Montpetit wouldn't have the time necessary to make travel arrangements to attend the marriage.
- 104) Finally, on January 24, 2025 (the Friday before the visit on Monday), at 1600 hours, the defendant, Case Manager Brittany Sherlock approached the plaintiff "face-to-face" to inform him that the marriage application had been approved for Monday, but that, after the ceremony is finished, Julie Montpetit will have to leave the facility because her visits are suspended. (See Exhibit #15)
- of Since the plaintiff had never received any formal notice in writing, he asked defendant Case Manager Brittany Sherlock to provide the reasons for why Julie Montpetit has been suspended from visiting. Case Manager Sherlock responded, "you know why. it's the 3-way calls and all the stuff you're doing."
- 106) The plaintiff informed Case Manager Sherlock that Julie Montpetit had never made a 3-way call for him to which Case Manager Sherlock told the plaintiff that he'd be receiving a letter via institutional mail that night from the Warden concerning this matter.
- 107) The plaintiff told Case Manager Sherlock that, because they had waited until the last minute to inform him of the visit/marriage decision, he would need a

- new marriage application for the date of 2-26-25 (which was the date of the housing unit's next assigned visit, as inmates can only schedule marriages on visiting days, per policy)
- 108) Later that night (1-24-25) the plaintiff received the letter from the defendant, Warden Taggart Boyd, concerning Julie Montpetit's visiting suspension. It reads:

"This letter is to inform you, that all your visits

(virtual and incentive) with Julie Montpetit are suspended indefinitely. This is due to the overall security risk presented by Montpetit being complicit in helping you facilitate continuous violations of N.D.C.S. regulations. These violations include unauthorized business practices, participating in unauthorized electronic public communications, and unauthorized phone communications.

- 109) The plaintiff has never received any misconduct reports for any of the alleged violations in that letter and he disputes the accusations.
- 110) These ambiguous statements hide what the administration has implicitly said:

 You've lost your visits with your fiancé because she publishes your writings

 and interviewed you (once) for her podcast.
- 111) The plaintiff's verbal expressions and/or writings are not, nor have ever been, a threat to the safety, security, or good order of the institution. Therefore, are protected by the First Amendment, and this retaliation against the plaintiff for practicing his freedoms of speech and association violate the First, Fifth, Eighth and Fourteenth Amendments of the Constitution.

- Incarcerated people who have witnessed how the defendants have retaliated against the plaintiff for writing a book and speaking on a podcast are now scared to practice their own First Amendment freedoms because they don't want to lose communication privileges wit their loved ones, as did the plaintiff. Incarcerated people don't want to file grievances or speak publicly about the conditions they suffer because the harassment currently being received by the plaintiff has "chilled" them from wanting to do so.
- 113) Although not included within the formal letter, on January 28, 2025, defendant Warden Taggart Boyd stated via I.I.R. reply:

"The suspension occurred because of violations of video visitation, which you continue to do with different numbers. If you can't do it in visiting, you can't do it on video visit. Visit appropriately and you can visit again upon end of suspension." (See Exhibit #16)

- The plaintiff has never received any misconduct report for violating the rules and video visitation and the plaintiff disputes this allegation. This statement from the defendant, Warden Taggart Boyd, was another ambiguous response and the plaintiff has no knowledge of what this response is in reference to.

 Furthermore, the plaintiff questions why "video visit violation" was not a reason included within the formal letter from the Warden discussing the suspension of visits.
- Defendant Warden Taggart Boyd never responded to any more of the I.I.R. submitted by the plaintiff. In February of 2025, Taggart Boyd was replaced by defendant Craig Gable, who is now the Warden of the institution.

- Julie Montpetit and the plaintiff then arranged to be married on the next approved visiting date, which was scheduled for February 26, 2025.
- 117) Because Julie Montpetit poses no actual threat to the security of the institution, she emailed the Warden on 2-19-25 to request his special approval to allow her to visit after the wedding ceremony. The duration of normal visit is two hours.
- 118) Although Julie Montpetit has never violated any visiting policies, the defendant, Associate Warden Eric Steigger denied her request after claiming that she poses a "threat to the safety, security, and good order of the institution."
- On February 22, 2025 the plaintiff's cell was raided by Intel staff. The rough draft of this here lawsuit was confiscated during this search and withheld from the plaintiff for two weeks as the defendants reviewed the document.
- never returned. Even after submitting receipts and proof of purchase, the defendants stated that the plaintiff "couldn't prove that it belonged to him" and never returned it.
- 121) The plaintiff believed this search was further retaliation for his grievances and expressions of speech.
- On February 26, 2025, the plaintiff was allowed to be married to Julie

 Montpetit. Immediately after the twenty-minute ceremony was finished, the

 defendants escorted the plaintiff's wife out of the building.
- 123) The marriage was recognized by the State of Nebraska approximately March 7, 2025.

- On March 5, 2025, a memorandum was delivered to the inmate population discussing a newly implemented policy concerning the consequences of "phone violations," specifically 3-way calls. (Memorandum title: Standard Operating Procedure- Abuse of ICS Phone Privileges)
- 125) The punishment for committing a phone violation shall consist of a misconduct report and the person's phone number being blocked from the inmate's phone list for 7 days on first offense, 14 days on second offense, 21 days on third offense, and so on and so forth.
- 126) For the plaintiff's alleged "phone violation" (i.e. podcast interview), Julie Montpetit (wife) has been removed from his phone list, as well as email and visiting list, for over six months at the time of this complaint, and has never received any misconduct report for this alleged phone violation.
- 127) After the distribution of this memorandum, the plaintiff submitted an I.I.R. requesting to receive "equal treatment" from the defendants, asking for the block to be removed from Julie Montpetit's phone number.
- 128) Sergeant Hank removed the block from Julie Montpetit's phone number on March 7, 2025 but the plaintiff is still not able to dial his wife's number.
- 129) The plaintiff asked defendant Unit Manager Taylor Kester to email Sergeant Hank to ask why his wife's phone number was still restricted. Sergeant Hank replied that he had removed the block on his end but that the Warden has a special block on this phone number that only could be removed from the Warden himself.
- 130) On March 2, 2025, the plaintiff had submitted an I.I.R. to the new Warden, requesting that he review these restrictions and reverse the last

administration's decision to censor communication between husband and wife.

The plaintiff delineated how these restrictions came about due to the publishing of his book and having been interviewed (once) for his wife's podcast.

131) This I.I.R. to the Warden was (again) intercepted by defendant Unit Manager Taylor Kester, who responded to it on March 13, 2025, stating:

"You were subsequently told that those actions were and are against the rules and continued to break them. Usually, after one year you may ask for a reinstatement." (see Exhibit #17)

- This response is not only a lie, but also a violation of the plaintiff's right to request the Warden to review/reverse a decision. Because only the Warden has the power/authority to reverse these restrictions, defendant Unit Manager Kester has no right to intervene between the plaintiff's appeal and the Warden. Unit Manager Kester has prohibited the plaintiff from requesting the new Warden, Craig Gable, to review the restrictions that have unnecessarily been in place for over six months.
- 133) Concerning the substance of the response itself, the plaintiff has <u>not</u> continued to publish any books, nor has he been interviewed for her podcast, although the plaintiff believes both of these expressions are protected under the First Amendment's freedom of speech and association.
- 134) The defendants have been retaliating against the plaintiff for practicing his protected freedoms since November 14, 2024, and have been accusing him of

- "abusing the grievance procedures as he exhausted his complaints. Although it was made difficult for the plaintiff to exhaust the N.D.C.S. grievance remedies, his complaints have been heard by every level of the administration through the provided procedural methods.
- 135) Because the plaintiff is housed in a Controlled Management Unit designated for inmates classified to super-maximum security, "classification reviews" are held every 6 months to determine if an inmate's behavior meets the criteria to be promoted out of the Controlled Management Unit and placed back into general population.
- 136) The plaintiff has been housed in this unit (F1) for 21 months already (since 7-14-25) which is the longest time that any inmate on his unit has been housed there. The plaintiff has maintained excellent behavior, but was informed by defendant, Case Manager Brittany Sherlock, that no "recommendation of custody-promotion" will be given until the plaintiff stops attempting to communicate with his wife.
- 137) The plaintiff must stop communicating with his wife if he ever desires to leave the Controlled Management Unit- a unit intended to deter violence, gang activity, and drug trafficking. The plaintiff should never have been prohibited from communicating with his wife in the first place.
- 138) These facts further prove the retaliation, harassment, and abuse of power from the defendants, toward the plaintiff. These actions violate the plaintiff's right to substantive due process and equal treatment under the Fifth and Fourteenth Amendments.

- its way to the Warden, the plaintiff has written an actual letter to the defendant, Warden Craig Gable, requesting the defendant to relieve the plaintiff from these ongoing constitutional violations, but the plaintiff is yet to receive a response or any relief.
- 140) After six months of retaliation for publishing a book without having requested permission from the administration, on May 12, 2025, the plaintiff received a response back from current grievance series #555616771 stating that "you do not need permission from NDCS to publish your book. Incarcerated individuals will not be allowed to purchase your book while under care of NDCS." This response directly contradicts earlier statements from the administration that repeatedly claimed the plaintiff had violated policy/procedure by publishing a book without having received permission from the Warden.
- 141) The administration has alleged for over six months that the plaintiff has operated a business enterprise, due to the publishing of his first book, but now begins to state that permission is not required. However the administration has still not reversed any of the restrictions placed upon the plaintiff's wife and still prohibits them from communicating or visiting each other indefinitely.
- 142) As of the date this complaint was filed, neither the new Warden or the defendant, Director Rob Jeffreys, have taken any corrective action to relieve the plaintiff of these constitutional violations, causing "irreparable harm" to the plaintiff and his wife.

- Due to practicing his protected freedoms of speech and association, the defendants of this suit have retaliated against the plaintiff by prohibiting all communication between him and his wife, attempting to deny his right to marriage, and blocking several associates (Elizabeth Hettrick, Melissa Breckenridge, Greta Ericson) from his email list. Additionally, the defendants have harassed the plaintiff by subjecting him to countless unnecessary searches, confiscating personal property and reading his legal work, lost all of his clothing in the laundry, and refused to promote his custody level to move him out of the Controlled Management Unit.
- The First Amendment requires the existence of written regulations to govern prison officials' discretion, and the N.D.C.S. policy/procedures have no regulations against an inmate publishing a book or being interviewed for a podcast (which qualifies as a public media outlet). The only regulation in place concerning inmate interviews states: "Incarcerated individuals shall not receive compensation or anything of value in exchange for, or as a result of, participation in an interview."
- 145) The plaintiff never received, nor requested, nor was offered any compensation for the podcast interview, and no "Sons of Sam" laws were violated within any of the plaintiff's expressions of speech.
- 146) Meaningful accountability and oversight depend upon the public's ability to access information about what is happening inside of correctional facilities.
- "Publishing a book" or any articles for journals/newsletters does not constitute a "business enterprise", as alleged by the defendants. The First Amendment protects the right to publish.

- 148) The admissions from the defendants have proven the causal connections between the plaintiff's "protected speech" and the "adverse actions" of the defendants. The adverse actions of the defendants are not justified, nor are they reasonably related to legitimate penological interests.
- The plaintiff requests this court to examine the alleged "threat to security" more closely to determine if Julie Montpetit (wife) poses any real threat or if it is just an excuse being used to punish the plaintiff. The right to "intimate association" is not terminated due to the plaintiff's incarceration.
- association, and the devastating impact of the failure to accommodate these rights, weighs more heavily in favor of the plaintiff than any deference generally owed to the defendants. Phone calls and emails between the plaintiff and his wife are already recorded/monitored be the defendants, therefore, the defendants may punish the plaintiff for any "phone visitations" as they may occur- but completely prohibiting the plaintiff from speaking with his wife does not serve any legitimate penological interest.
- No "visiting regulations" have ever been violated by the plaintiff or his wife, thus no legitimate penological interest is served by indefinitely suspending all visits between these parties.
- 152) This retaliation has created the "chilling effect" that deters the plaintiff, as well as others, from expressing their voice to the public, in violation of the First Amendment of the United States Constitution.

- 153) When speech is directed outside of a prison, there should be limited restrictions and this speech should not be limited based on the defendant's dislike of the content.
- 154) The plaintiff is suffering psychologically and emotionally due to not being allowed to communicate with his wife.
- 155) The plaintiff has begun experiencing an ongoing dissociation and detachment from life, continuous anxiety and fear of how the defendants may retaliate next, as well as depression that stems from his inability to have intimate associations.
- 156) For no real reason, the defendants have removed the plaintiff's wife from his life, leaving an empty void and lack of meaning. The plaintiff doesn't know if he'll ever be allowed to communicate with his wife again, and, if so, without retaliation, which has left the plaintiff feeling helpless and hopeless.
- 157) These complaints have been brought to the attention of prison officials, including mental health psychiatrists, but the defendants have ignored the complaints.
- 158) The plaintiff has been deprived of this basic human need, his association with his wife, and the defendants have acted with deliberate indifference by knowing of these conditions and failing to respond in a reasonable manner:
- 159) The "irreparable harm" that the plaintiff continuously suffers because of the retaliations is cruel and unusual punishment, in violation of the Eighth Amendment of the United States Constitution.
- 160) Deprivation of any constitutional rights, such as freedom of speech and association, and freedom from cruel and unusual punishment and unequal

treatment, satisfies the "irreparable injury" that the plaintiff needed to prove in order to receive injunctive relief.

V. LEGAL CLAIMS

- 161) The retaliation from the defendants violated plaintiff Nicholas Ely's rights and constituted a Freedom of Speech and Association violation under the First Amendment of the United States Constitution.
- 162) The deliberate indifference of the defendants violated plaintiff Nicholas Ely's rights and constituted cruel and unusual punishment under the Eighth Amendment of the United States Constitution.
- 163) The unequal treatment and lack of due process by the defendants violated plaintiff Nicholas Ely's rights to equal treatment and due process under the Fifth and Fourteenth Amendment of the United States Constitution.

VI. PRAYER FOR RELIEF

WHEREFOR, plaintiff respectfully prays that this court enter judgment granting plaintiff:

164) A declaration that the acts and omissions described herein violated plaintiffs' rights under the Constitution of the United States and the laws of Nebraska.

- 165) A preliminary and permanent injunction ordering defendants Rob Jeffreys,
 Taggart Boyd, Craig Gable, Shawn Freese, Eric Steigger, Frank Howard, Taylor
 Kester and Brittany Sherlock to reverse Julie Montpetit's visiting suspension
 and allow the plaintiff to communicate with Julie Montpetit via phone calls
 and emails, as Julie Montpetit is the legal wife of the plaintiff. Additionally,
 order all mentioned defendants to allow the plaintiff to publish his writing and
 participate in interviews with public media outlets, free from retaliation.
- 166) Compensatory damages in the amount of \$25,000 against each defendant, jointly and severally.
- 167) Punitive damages in the amount of \$5,000 against each defendant, and the amount of \$10,000 against defendant Taylor Kester.
- 168) A jury trial on all issues triable by jury.
- 169) Plaintiff's cost in this suit.
- 170) Any additional relief this court deems just, proper, and equitable.

I said, I'm not Nikko Jenkins and I haven't been speaking to anyone about crime or criminal activity Cpt Howard then states that I cannot publish a book or profit from any enterprise without permission from the warden, to which I replied that I was unaware that I could not have my writings published without permission. I further explained to him that I was never informed of this policy from the responses of any grievances Ire tiled (concerning my book being censored), not from any previous discussions I'd had about my book with case managers, unit staff or Associate Warden Sloup. I then explained to Cpt. Howard how I had spoken to Associate Marden Sloup a few weeks prios, who had congratulated me on publishing my book and approving of how I'd chosen to utilize my time in a constructive mannes I explained how nobody ever said to me that I had violated and rules by having my writing spublished without having received implicit permission from the worder

Cpt. Howard then explained how the administration can't technically stop me from publishing my writings but advised me about how a little transparency between myself and the administration would help 1,000/11313 (pt Howard explained further how transparency would be nice due to my "history, which has caused a knee-jeck reaction from the administration I acknowledged his concerns and explained how I'd be more than happy to be transparent with the administration about my writings and my projects if that's what they'd like but, before this discussion, I'd peeu mudmare of and broppen or concern I argued to Cpt. Hasard how their knee-jerk reaction was an over-reaction, like if a police officer were to take someone to jail as the consequence of a speeding ticket. Ept. Howard stated, I've read your book already... what is your goal from all of this? What are you hoping to achieve?" I explained to Cpt. Howard the premise of my book and how the philosophy that I believe in is "Reform Start's With US" I explained how I wanted to share the tomor importance of integrity and education with the inmate population. I explained how I'd like to build a bridge between the administration and the inmates, getting rid of the us versus them mentality; how I want to stop the violence amongst each other and staff, and how I want us Conmates) to rehabilitate ourselves via reading and receiving an education; how I want to promote positivity and give back to society Cpt. Howard said he believes nothing is wrong with my book besides the title (The Prisoner Manifesto) claiming it to be too extreme

his liking. He stated that I shouldn't use inmates nicknames within the acknowledgement section. He said if I remove the acknowledgement section and change the title, there's no regson for denying my book from Nebraska facilities Cpt. Howard stated that the material within my book poses no threat to the salety, security, or apod order of the institution, but requested transparency going forward I then asked about whether Julie Montpetit will be added back to my phone remail list now that we've had a constructive conversation Cpt. Howard said, You need to ask the warden because the decision is ultimately his, but there is no reason for why you shouldn't be allowed to communicate with her - long as you're transparent Cpt Howard assured me that the removal of Greta Ericson (mother) and Elizabeth Hetrick (friend) from my email account was a mistake, that it was never suppose to happed and would be fixed immediately.
